**The 9/11 Commission Chair Thomas H. Kean and Vice Chair Lee H. Hamilton wrote in their book *Without Precedent: The Inside Story of the 9/11 Commission* that they were "setup to fail"**. The post-9/11 global order is based on this false account of 9/11. It has caused countries to spend more for security and surveillance than they may have done otherwise.

**No proof is available to the public that the debris found at the Pentagon is that of American Airlines Flight 77 that is alleged to have struck the Pentagon on 9/11.** In criminal cases, the burden of proving the defendant's guilt is on the prosecution, and they must establish that fact beyond a reasonable doubt. The U.S. has yet to do that.

**According to the "most influential English language philosopher of the nineteenth century" John Stuart Mill (1806-73):**

He who knows only his own side of the case knows little of that. His reasons may be good, and no one may have been able to refute them. But if he is equally unable to refute the reasons on the opposite side, if he does not so much as know what they are, he has no ground for preferring either opinion. . . Nor is it enough that he should hear the opinions of adversaries from his own teachers, presented as they state them, and accompanied by what they offer as refutations. **He must be able to hear them from persons who actually believe them . . . he must know them in their most plausible and persuasive form.**

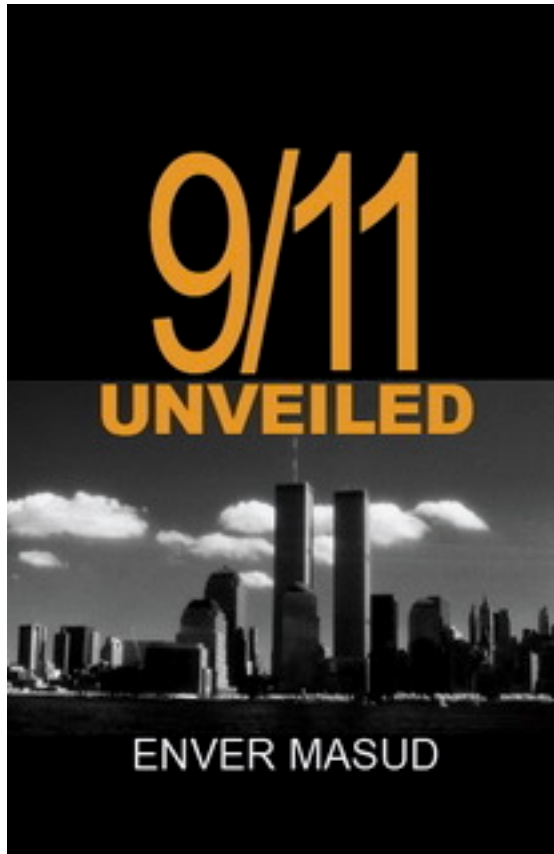
