

THE OFFICIAL, 9/11 CONSPIRACY THEORY IS FATALLY FLAWED

Introduction

Ninety-five years before this event we call 9/11, on September 11, 1906, Mohandas Karamchand Gandhi, a 37-year old lawyer, rose to address the packed Empire Theatre in Johannesburg, South Africa.

This speech was the first salvo in the nonviolent movement that would overthrow the British Empire. This movement came to be known as Satyagraha — the force which is born of truth and love (or nonviolence).

Today, another empire oppresses the world with its so called "war on terror".

• **Flight 93:** Why was there "nothing larger than a phone book" at the crash site, and debris from the plane spread over a few miles?

• **Bin Laden and the hijackers:** Why does the FBI's Most Wanted poster for Bin Laden not charge him with 9/11 while British media claim that some of the hijackers are alive? Why are there are no Arab names on the airlines' 9/11 passenger lists available to the public?
