- “This is a memo that describes how we’re going to take out seven countries in five years, starting with Iraq, and then Syria, Lebanon, Libya, Somalia, Sudan and, finishing off, Iran.” — reported by Gen. Wesley Clark, Supreme Allied Commander, NATO
- Chaos as Strategy

COMPETITION FOR OIL



- Syria intervention plan fueled by oil interests — not concerns about chemical weapons
- Massacres of civilians are being exploited for narrow geopolitical competition to control Mideast oil, gas pipelines
- Assad refused pipeline agreement with Qatar
- Military support of Israeli energy grab

SYRIA SUSPECTED IN 2013



- Syria was suspected of using chemical weapons
- UN reports suggested the rebels might have access to chemical weapons
- A number of CIA analysts threatened to resign if strong dissent not noted in public report
- CIA Director Brennan and Director National Intel Clapper backed down
- Are chemical weapons worse than other weapons? British propaganda?

WHITE HELMETS IN THE NEWS



- Often source for news of Syria
- Founded in collaboration with USAID's Office of Transitional Initiatives — wing that promotes regime change
- \$23 million from USAID provided through Chemonics — contractor in Washington, DC
- ISIS created by Qatar, Saudis, U.S.

'ABSOLUTELY NO EVIDENCE'



- Theodore A Postel: Professor Emeritus of Science, Technology, and National Security Policy, M.I.T.
 - “absolutely no evidence that this attack was the result of a munition being dropped from an aircraft”
 - “absolutely no evidence that would indicate who was the perpetrator”
 - “how was the president initially misled about such a profoundly important intelligence finding?”

HUMANITARIAN INTERVENTION?

- Permissible if authorized by the United Nations Security Council
- Catholic church's criteria for a Just War:
 - the damage inflicted by the aggressor on the nation or community of nations must be lasting, grave, and certain;
 - all other means of putting an end to it must have been shown to be impractical or ineffective;
 - there must be serious prospects of success;
 - the use of arms must not produce evils and disorders graver than the evil to be eliminated.
- The Quran's definition of a Holy War is virtually identical with that of a Just War

U.S. MORAL AUTHORITY?

- U.S. used AGENT ORANGE in Vietnam (1961 – 1972)
 - Powerful mixture of chemical defoliants used by U.S. military forces during the Vietnam War
 - 400,000 people reported killed or maimed
 - Vietnam claims 500,000 children born with serious birth defects
 - 2 million people are suffering from cancer or other illness
- Afghanistan, Iraq, Libya, Somalia, South Sudan ...

JUNE 2017 UPDATE

- Syria surrendered chemical weapons to OPCW in June 2014
- 12 million refugees (65% of all refugees) are from Syria
- U.S. policy responsible for extending Al Qaeda in Syria
- Former Israeli Defense Minister confirms Israeli collaboration with ISIS
- U.S. missile strike on April 6 — U.S. intelligence found no evidence Syrians used CW
- Trump threatens Syrian President Bashar al-Assad over ‘planned new chemical attack’ — no evidence, only assertions
